

Dear Parent / Carer

At Stoneygate Rugby Football Club (SRFC), we aim to provide a positive, fun, safe environment for all of our players. In order to achieve this we need to work in partnership with parents, children and coaches. Due to new General Data Protection Regulations (GDPR) which came into effect in May 2018, organisations must now provide parents with an opportunity to opt in or out of any data sharing. The personal data we hold is used to support our coaches and players.

We will not give information about your child to anyone outside SRFC without your consent unless the law and our rules permit it.

To ensure we are meeting the new requirements, we need to seek your consent for some of the ways we use information about your child.

If you're not happy for us to use information in the ways we list below, that's no problem – we will accommodate your preferences.

Similarly, if you change your mind at any time, you can do this by completing the consent withdrawal form. This form is available on our website. In addition, you can let us know by email.

Conditions of Use:

- This form is valid for the duration of your child's time at SRFC (mini/junior). Your consent will automatically expire once your child leaves or turns 18 years of age.
- SRFC will not re-use any photographs or recordings of your child that are incompatible with the original purposes explained to you;
- If we use photographs of individual players, we will not use the full name of any child in any accompanying text or caption unless consent has been given, nor will we include any other personal information;
- We may use group or class photographs or footage with very general labels;
- We will only use photographs and videos of pupils who are suitably dressed;
- Parents should note that websites can be viewed throughout the world and not just in the United Kingdom, where UK law applies.
